**A RESOLUTION TO APPROVE BUEDINGEN PARK OSLAD
IMPROVEMENT PROJECT**

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois, and

WHEREAS, The Tinley Park-Park District was awarded an Open Space Land Acquisition and Development (OSLAD) Grant through the Illinois Department of Natural Resources for needed park improvements at Buedingen Park located at 16612 Cherry Hill Avenue which include demolition and removals, site grading, storm drainage, concrete flatwork and curbing, asphalt paving, pickleball and basketball court construction, playground installation, fence installation, site furnishings and landscaping ; and

WHEREAS, Staff recommends Hacienda Landscaping Inc. who was also the lowest responsive, responsible bidder from the bid opening held on February 15th, 2024 for this project; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve this project to Hacienda Landscaping Inc. for \$1,192,945.00

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:
