A RESOLUTION TO APPROVAL OF OFFICE TRAILER RENTAL TO UNITED RENTALS

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois, and

WHEREAS, the project manager has secured three proposals for the construction trailer needed for the Abatement and Demolition Project at the Former Tinley Park Mental Health Facility. This construction trailer will serve as project manager's office on site; and

WHEREAS, we are still working with ComEd and a contractor to determine the electric utility needs as well. Our hope is to have this trailer in place before the bid is in place so that he has a facility onsite as the contractor is mobilizing; and

WHEREAS, the total cost is for a 12-month rental and includes delivery and pick-up; and

WHEREAS, staff recommends United Rental for the office trailer rental for \$22,435; and

WHEREAS, the Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve the office trailer rental to united rentals for \$22,435; and

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

SECTION 1: The Preambles hereto are hereby made a part of, and an operative provision of, this Resolution as if fully restated herein.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.
