### Cleanup

#### Welcome to the April Remediate 280 newsletter

We're excited to share that we're taking the next significant steps in the cleanup of the former Tinley Park Mental Health Center site.

We will be opening the bidding process for removing asbestos and other materials and wastes from inside the property's buildings and for demolishing all buildings on the site. The bidding process will remain open for 30 days, and we anticipate the work to begin sometime this summer.

Once the bid is awarded and in place, we will provide residents with more details and updates on all aspects of these phases of cleanup and the timing for the start of this work. Importantly, this cleanup work will include many precautions to ensure the safety of the surrounding community, including third-party air monitoring and safety protections for workers at the site.

### Oversight

Overseeing this significant cleanup project is our expert team: former Illinois EPA Director Renee Cipriano, leading environmental attorney Elizabeth Harvey, and Project Manager Michael Maloney, with additional oversight of the IEPA. Our experts are helping us ensure the safety of environmental work done at the site and make sure we receive the IEPA's stamp of approval to redevelop the site once clean-up work is done.
