A RESOLUTION TO APPROVE PLAYGROUND REPLACEMENT PIECE THROUGH PLAY ILLINOIS, LLC

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois; and

WHEREAS, the Neos system at Sutter Playground located within Community Park has not worked now for a while. Staff has attempted to identify the issue (electrical) without success. Additionally, some of the sensors prior to its not working were in need of replacement as well; and

WHEREAS, we came across a similar piece at the NRPA Conference recently and feel it would be a great piece to replace the Neos with. The new piece, Movmnt by Burke, is very similar in its features but features a crank to energize the unit; and

WHEREAS, this replacement piece is part of the Sourcewell contract #010521-BUR. Additionally, the replacement will be completely ADA accessible. Once the piece is ordered, staff will work to secure proposals for installing the piece which will include some safety surface modifications at the playground area as well.; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve playground replacement piece through Play Illinois, LLC for \$17,022.45.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:
