

RESOLUTION NO 24-R-52

A RESOLUTION TO APPROVE SCISSOR LIFT PURCHASE

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois; and

WHEREAS, this year staff budgeted \$18,000 to purchase a scissor lift for use around the Tony Bettenhausen Recreation Center and many other applications; and

WHEREAS, the unit would replace the existing single man basket lift and provide much more versatility in being able to reach items within the facility such as lighting, vents, and other necessary components requiring vertical reach; and

WHEREAS, the recommended unit is a used unit from United Rentals and has recently been inspected and new batteries installed. We will look to declare the existing 2005 lift as excess in an upcoming meeting and auction the unit; and

WHEREAS, staff recommends purchasing the unit from United Rentals for \$15,649

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve scissor lift purchase to United Rental for \$15,649.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

SECTION 1: The Preambles hereto are hereby made a part of, and an operative provision of, this Resolution as if fully restate herein.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.


