

**RESOLUTION NO 24-R-60**

**A RESOLUTION TO APPROVE PUMP EQUIPMENT RENTAL**

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois; and

WHEREAS, to begin to remove water from the property formerly known as the TPMHC, the district must rent equipment to begin pumping out the stormwater that has collected on the site. The equipment includes a generator to operate the pump as power on the property has been off since the State of Illinois turned it off in December of 2023; and

WHEREAS, the equipment being rented will include a pump with a generator, hoses, strainers and sleeves; and

WHEREAS, the water onsite has been tested and is clean, the district sought a permit for discharge from the IEPA and is currently awaiting approval; and

WHEREAS, staff is recommending United Rentals to rent the equipment for \$11,445.38; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve pump equipment rental to United Rentals for \$11,445.38.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

SECTION 1: The Preambles hereto are hereby made a part of, and an operative provision of, this Resolution as if fully restated herein.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.

SECTION 3: That this Resolution shall be in full force and effect on the date approved and passed by the Board of Commissioners of the TINLEY PARK-PARK DISTRICT.
