

RESOLUTION NO 24-R-78

**A RESOLUTION TO APPROVE MCCARTHY PARK BALL FIELD FENCE
INSTALLATION PROJECT**

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois, and

WHEREAS, bids were opened on Tuesday, November 12, for the Ball Field Fence Replacement Project at McCarthy Park-Therault Field, Memorial School Park and Canine Campus Dog Park; and

WHEREAS, work will consist of replacing the McCarthy Park-Therault Field outfield fence, Memorial School backstop and sideline fencing, and access gate at Canine Campus Dog Park; and

WHEREAS, eight companies were sent invitations to bid with five companies picking up specification and one contractor, Classic Fence, submitting a bid for this project and the reference check results for Classic Fence were all very positive; and

WHEREAS, the base bid is \$61,590. Alternates were sought to increase the height of the outfield fence at McCarthy ballfield and staff is recommending Alternate B, 8' high fencing for an additional \$10,690.00.

WHEREAS, staff recommends Ballfield Fencing Installation Project including Alternate B to Classic Fence Inc. for \$72,180.00; and

WHEREAS, the Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve the McCarthy Park Ball Field Fencing Installation project including Alternate B to Classic Fence Inc. for \$72,180.00,

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

SECTION 1: The Preambles hereto are hereby made a part of, and an operative provision of, this Resolution as if fully restate herein.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.

SECTION 3: That this Resolution shall be in full force and effect on the date approved
