A RESOLUTION TO APPROVE BRICK PAVER INSTALLATION PROJECT

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois, and

WHEREAS, bids were opened on Tuesday, November 12, for the Brick Paver Installation Project at Canine Campus Dog Park and Vogt Visual Arts Center; and

WHEREAS, work will consist of replacing existing limestone at the dog park shelter pavilion areas which has been an ongoing issue and complaint for members, as well as the VVAC gazebo walkway with new brick paver areas; and

WHEREAS, we are planning to offer Memorial Pavers for purchase within these areas as an addition to our Memorial Tree and Memorial Bench Program; and

WHEREAS, eight companies were sent invitations to bid with five companies picking up specifications and three contractors submitting bids for this project and Innovation Landscape, Inc. was the lowest responsible and responsive bidder; and

WHEREAS, staff recommends Innovation Landscape, Inc. for the Brick Paver Installation Project for \$86,750.00; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve the Brick Paver Installation Project to Innovation Landscape, Inc. for \$86,750.00,

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:
