Staff Reports:

Executive Director, Shawn Roby reported on:

- -Resolution 29 is the Directors Goals 2024-2025
- -Resolution 30 is approval of the Tetra Tech agreement modification 3 -Tetra Tech has a few extra items they are working on.
- -Resolution 31 is the Tetra Tech-Wetland Delineation work. Even though IDNR confirmed, at least in the grant portion of the agreement, that there is nothing they were concerned with. We do think there might be something worth looking into. We are going to have a wetland delineation done around the property. There are about 4 or 5 areas that they want to confirm whether they are wetlands. We are having this done to stay ahead of this because once you start construction and demolition you don't want to be interfering with anything.
- -Resolution 33 was the approval of the property gate for TPMHS for MBE Fence Inc. There is currently a rickety gate at the TPMHS. With the amount of traffic that will be going in and out of the location, it is important to have a sturdier gate. Once the gate is no longer being used at the property, Superintendent of Parks Ryan Veldman plans to use it in another location.
- -Resolution 34 is the approval of vehicle purchase.
- -Resolution 35 is the approval of playground replacement piece. Similar to what we have now but self-powered. It does not require electricity to be connected, kids crank a wheel to operate it. We will be working to locate an installer of the new piece but it is going to take 8-10 weeks for delivery.
- -Ordinance 05 is a surplus ordinance. We just replaced our phone system, and we would like to get rid of the old components.
- -Resolution 36 approves the appointment of the Board Officers as is typical this time of year.
- -Resolution 37 approves the appointment of the legal firm Odelson, Murphey, Frasier & McGrath LTD.
- -Resolution 38 approves the appointment of Kelly Jones as the Board Secretary.
- -Ordinance 04 approves the 2024-2025 Budget and Appropriations Ordinance.
- -White Water Canyon Water Park will open on June 1st.
- -June 19th summer Day Camp will begin.

-Tot Time Preschool Graduations ceremonies are today and tomorrow for 3- & 4-year-olds.

Project Manager Mike Maloney reported on:

- -Site Preparations are ongoing.
- -TPPD on Site-Clean up continues.
- -Site walk through with qualified contractors was conducted.
- -The public needs to be reminded that the TPPD has owned the property for approximately 60 business days. Much has been accomplished in this time period.
 - -Vegetation cut Back.
 - -Three underground storage tanks have been removed and transported off site.
 - -Site fencing installed.
 - -Security improvements.
 - -Environmental Remediation and Demolition Bid Documents published according to procedure.
 - -Planning for redevelopment discussions have started.
- -We have learned a lot about the property and have recently realized that Tinley Park Public Works has installed an internal valve in the discharge line of the main drainage system to control the vast amount of wastewater from the property. The valve has been installed in the line west of the property but east of the women's shelter property. The line is on the north side of Timber Road. There has been minimal water entering the system from the Tinley Park-Park District property.
- -If the water service from Tinley Park Public Works coming into the property was accidentally energized and if the valve in the main drainage line is closed the property would flood and cause major damage to the property and possibly other locations near the property.
- -The Tinley Park Public Works has not communicated with the Tinley Park-Park District about drainage procedures.
- -This project will require water and drainage to keep Tinley Park safe.
- -We have a long journey ahead, but we are off to a good start.
- -Stay focused, positive, and safe.
