**A RESOLUTION TO APPROVE THE PURCHASE OF COMPUTERS FROM DELL CORPORATION**

WHEREAS, the District is recommending the replacement of 16 laptops. These units will replace high usage systems 4 to 5 years old some of which have components that are slowly failing; and

WHEREAS, once the new systems are installed the best of the older systems that are not having issues will be repurposed to replace the less demanding older workstations; and

WHEREAS, the remaining 6 systems along with all the older systems as well as any other aged equipment will be properly removed and recycled; and

WHEREAS, the staff recommends the Board approve the purchase of sixteen new laptops from Dell Corporation for the cost of \$42,678.40; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve the purchase of sixteen new laptops from Dell Corporation for the cost of \$42,678.40.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.


