WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois; and

WHEREAS, the Park District has contracted with Tetra Tech to update the 2014 Phase 1 ESA, Hazardous Materials Survey, and Asbestos Re-Survey on the former mental health site property; and

WHEREAS, Tetra Tech has provided modification request #8 to the existing contract for (a) and additional 12-weeks of oversight of ongoing abatement and demolition activities and (b) a 12-week extension of ongoing technical support by Tom Hahne; and

WHEREAS, Tetra Tech recognizes that there is limited funding and will endeavor to minimize our costs in support of this important redevelopment project.

WHEREAS, the Modification request is going to move the contract up an additional \$80,940.00; and

WHEREAS, the Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve the Tetra Tech modifications request in the amount of \$80,940.00.

Modification 8: Task 8A and 8B - Technical Support

Dear Mr. Odelson:

Tetra Tech is providing this cost estimate and modification (MOD) request number (No.) 8 to the original contract and scope of work dated July 11, 2023, and authorized on August 8, 2023. The MOD request has been revised to include additional funding for Task 8a and 8b as summarized below.

This MOD is for two tasks; the first (Task 8) is being modified to reflect the greater than expected support provided for asbestos abatement oversight, conducted by Caryn Castillo. The prior MOD included costs for 20 weeks of oversight of ongoing abatement and demolition activities. The MOD will include two subtasks (8A and 8B).

Task 8A is for onsite and offsite support of abatement activities conducted by Caryn Castillo. The prior MOD estimated support for 20 weeks at an estimated 24 hours per week as well as some support for laboratory analysis and local travel. Ms. Castillo has more recently been requested to support work that has been up to 5 days/week. Furthermore, the duration of the work has been extended and likely will require support until June 2025. As a result, this request increases the weekly support to 32 hours and the work support duration by 12 weeks.

Task 8B is for ongoing project management and technical support by Tom Hahne for the same time duration. The ongoing support reflects the same timeline extension of 12 weeks from the prior request. Tetra Tech notes that there also was an error in the rate assumed, which has been corrected.

Task 9 is also active, but no additional funding is requested as that work has been largely completed except for the reporting including recent sampling results.

Tetra Tech notes that the actual scope and level of support may change and result in less or more support as necessary to properly oversee and document the asbestos abatement and demolition activities. The estimated duration of abatement oversight work is estimated based on our understanding of the work duration of abatement activities and may be subject to change.

The scope of work (SOW) for Task 8 includes estimated labor costs, laboratory costs, equipment rental (as necessary), and local travel on a weekly basis. Actual costs will be incurred and billed on a time and materials basis. The cost breakdown is attached.
