A RESOLUTION TO APPROVE TRACTOR EQUIPMENT PURCHASE

WHEREAS, the Tinley Park-Park District ("District") is located in Cook & Will Counties of Illinois, and

WHEREAS, the purchase of a large tractor, which will aid in many projects but primarily assist with the Former Tinley Park Mental Health property, was included in the 2025-2026 budget; and,

WHEREAS, this new tractor will be able to operate a large rotary mower which the District already owns for maintenance mowings at Former Tinley Park Mental Health the site and for general use around the property, including material handling; and,

WHEREAS, staff were able to source the tractor through Sourcewell Cooperative Purchasing under contract #082923-DAC; and

WHEREAS, There is approximately an 8–10-month lead time, however our local vendor Shorewood Home and Auto was able to locate one on the lot in Kansas. Freight for the unit is an additional \$2,500 which will be paid directly to the dealership and is not included in the unit contract pricing; and,

WHEREAS, staff recommends Deere and Company for Tractor Equipment Purchase through Sourcewell Contract #082923=DAC for \$99,338.41; and,

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve Deere and Company for Tractor Equipment Purchase through Sourcewell Contract #082923=DAC for \$99,338.41.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

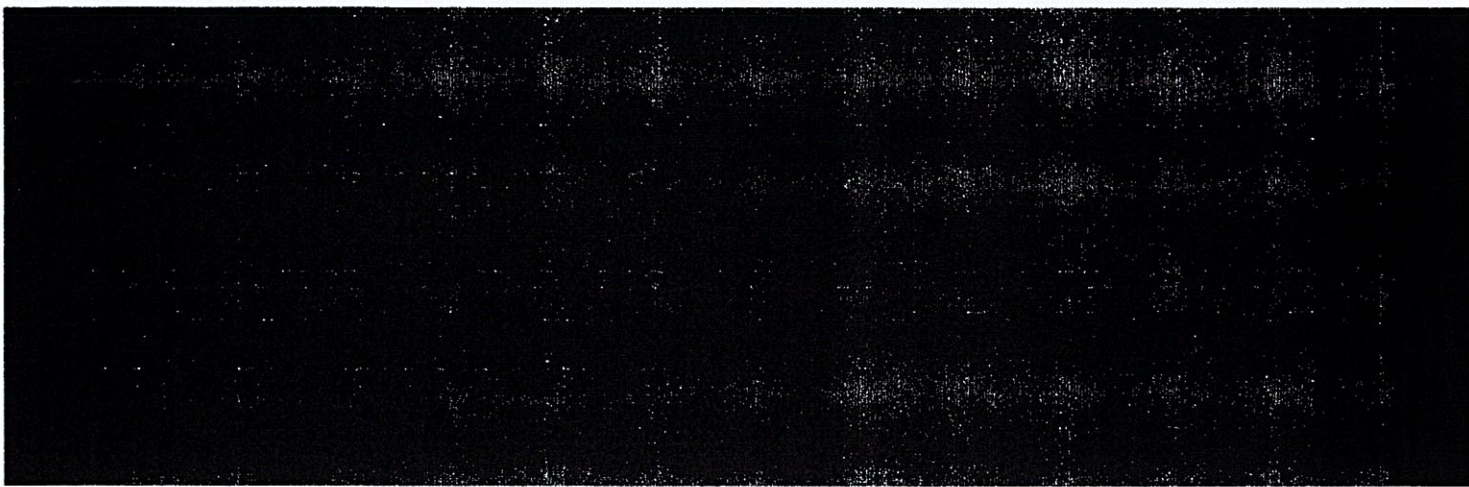




