

## **ORDINANCE NUMBER 25-O-02**

### **AN ORDINANCE DECLARING AS SURPLUS AND AUTHORIZING THE SALE OR OTHER CONVEYANCE OR DISPOSAL OF SURPLUS PERSONAL PROPERTY OF THE TINLEY PARK-PARK DISTRICT, COOK COUNTY, ILLINOIS.**

WHEREAS, the Tinley Park-Park District, Cook County, Illinois ("Park District") owns personal property used in connection with the operation of the Park District and described as follows:

Hereinafter known as the “Property”; and

WHEREAS, the Park District has determined that the Property is beyond its useful service life; and

WHEREAS, pursuant to Section 8-22 of the Park District Code (70 ILCS 1205/8- 22) (“Code”), every park district is authorized to sell or convey any personal property that in the opinion of three-fifths of the members of the Board of Park Commissioners then holding office is no longer necessary, useful to, or for the best interests of the park district, in any manner that they may designate and with or without advertising; and

NOW, THEREFORE, IT IS HEREBY ORDAINED by the Board of Park Commissioners of the Tinley Park-Park District, Cook County, Illinois, as follows:

Section 1. The Board finds that all of the recitals contained in the preamble to this Ordinance are true and correct and does hereby incorporate them in this Ordinance by this reference.

Section 2. The Board finds that the Property is no longer necessary, useful to or for the best interests of the Park District and authorizes staff to sell, trade, transfer, donate, dispose of or convey the Property.

Section 3. The Property shall be conveyed in “as is condition” without any warranties, express or implied at the time the benefactor takes possession of the Property.

Section 4. This Ordinance shall be in full force and effect after its adoption as provided by law.


