A RESOLUTION TO APPROVE TINLEY FITNESS POOL MAINTENANCE WORK

WHEREAS, the Tinley Park-Park District is located in Cook & Will Counties of Illinois, and

WHEREAS, numerous maintenance items collectively are becoming problems at the Tinley Fitness pool requiring corrective action this summer and necessitating closing and draining the pool; and,

WHEREAS, in conjunction with the work by contractors that includes cleaning the stainless steel gutters, regrouting the lane lap tiles that is approximately a 23 day process, and replacing the UV bulb, staff plan to perform in-house maintenance work such as replacing pool chemical lines, performing an acid wash and repair of the pool body, as well as removal of damaged sound baffles; and

WHEREAS, mechanical maintenance items such as the float replacement within the surge pit, deep cleaning of the DE filter and the replacement of in-line check valves need to be outsourced; and

WHEREAS, Landmark Aquatic, currently within the Buy Board Cooperative Purchase Program Contract #701-23, and of which we are a member, can perform this work; and,

WHEREAS, staff recommend Spear Aquatics / Landmark Aquatic Co. through Buy Board Cooperative Purchase Program Contract #701-23 for Tinley Fitness Pool Maintenance Work for \$33,142.02; and

WHEREAS, The Board of Commissioners of the Tinley Park-Park District finds that it is in the best interest of the District to approve Landmark Aquatic through Buy Board Cooperative Purchase Program Contract #701-23 for Tinley Fitness Pool Maintenance Work for \$33,142.02.
