

## RESOLUTION NO 26-R-19

### A RESOLUTION TO APPROVE AGENCY GOALS

WHEREAS, the Tinley Park-Park District ("District") is located in Cook & Will Counties of Illinois; and

WHEREAS, the Tinley Park-Park District Board of Commissioners is being presented with updated agency goals to replace the existing goals that have been in place since 2019; and

WHEREAS, the agency-level goals are intended to guide the development of staff-level goals, which are typically established on an annual basis and aligned with the overall direction of the District; and

WHEREAS, upon approval, the updated agency goals will remain in place through the next master plan cycle, at which time they will be reviewed and evaluated to determine whether any adjustments are needed; and

WHEREAS, the District received Board feedback and other public input during the planning process regarding the future direction and priorities of the District; and

WHEREAS, based on this feedback and input, staff recommends the addition of a sixth agency-level goal to be included with the updated goals; and

WHEREAS, staff recommends approval of the updated agency goals as presented.

WHEREAS, the Board of Commissioners of the Tinley Park-Park District find it is in the best interest of the District to Approve the updated Agency Goals.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the TINLEY PARK-PARK DISTRICT as follows:

SECTION 1: The Preambles hereto are hereby made a part of, and an operative provision of, this Resolution as if fully restate herein.

SECTION 2: The Request attached hereto as Exhibit 1, and made a part hereof, is hereby approved.
