WHEREAS, pursuant to Section 8-1(e) of the District Code the Board of Commissioners of the Tinley Park-Park District ("Board of Commissioners") adopted an ordinance establishing and promulgating law, rules and regulations for the safety and enjoyment of the public use of park District facilities, programs, and services; and

WHEREAS, pursuant to 5 ILCS 120/2.06(d) of the Illinois Open Meetings Act, the Board of Commissioners have periodically met and reviewed the minutes of all meetings of the Board of Commissioners that have been closed to the public; and

WHEREAS, the Board of Commissioners finds and hereby declares that the need for confidentiality still exists for minutes in the attached Exhibit 1; and

WHEREAS, the Board of Commissioners of the Tinley Park-Park District believes and hereby declare that it is in the best interest of the Park District and its residents that the minutes of the closed session meetings for the dates referenced above require confidential treatment and should not be made available for public inspection; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Park Commissioners of the Tinley Park-Park District, Cook and Will Counties, Illinois, that:

SECTION ONE: The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

SECTION TWO: The Board of Commissioners of the Tinley Park-Park District find and hereby declare that the closed session minutes or portions thereof expressly identified in exhibit 1 require confidential treatment and are not available for public inspection

SECTION THREE: This Resolution shall become effective upon its passage and approval as provided by law.

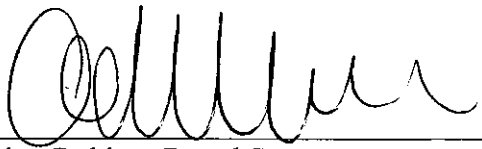
